

ORDINANCE NO. 2005 - 12

AN ORDINANCE AMENDING CHAPTERS 71, 72,
AND 73 OF THE NASHVILLE CODE OF ORDINANCES

WHEREAS, the Town of Nashville has received information concerning the state of traffic control and parking in the Town of Nashville, and

WHEREAS, after considering this information, deems it advisable to amend Chapters 71, 72 and 73 of the Nashville Code of Ordinances,

Chapter 71 of the Nashville Code of Ordinances is amended by adding the following:

Section 71.015 Motorcycle Parking. No vehicle other than a motorcycle or motor scooter shall park on any portion of any street that is marked as motorcycle parking. Any prohibited vehicle or material found to be parked in any area marked as motorcycle parking shall be towed away at the expense of the owner of the vehicle or materials and the owner subject to the penalties provided in Section 71.99.

Chapter 72 of the Nashville Code of Ordinances is amended by adding the following to **Schedule III:**

<u>Stop Location</u>	<u>Intersection</u>
Old Hickory Lane: Eastbound lane	Van Buren Street
Old Hickory Lane: Westbound lane	Van Buren Street
Molly's Lane: Eastbound lane	Van Buren Street

Chapter 73 of the Nashville Code of Ordinances is amended by adding the following:

Schedule IX: Non-Recreational Vehicle Parking Prohibited

Only recreational vehicles may park within the portion of the Jefferson Street parking area designated as motor coach parking. The parking of any car, truck, motorcycle, or other non-recreational vehicles within this area is prohibited.

BE IT FURTHER ORDAINED THAT, if any section or provision of the Ordinance or the application thereof to any person or circumstance shall be declared invalid, such invalidity shall not affect any of the other sections, provisions or applications of this Ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable. Additionally, should any provisions of Chapters 71, 72 and 73 be in conflict with the provisions of the Ordinance, this Ordinance shall prevail. Any provision of Chapters 71, 72 and 73 not amended by this Ordinance shall remain in full force and effect.

This Ordinance shall be in full force and effect from and after its passage by the Town of Council of the Town of Nashville.
