**COMMISSION BUSINESS**

**1. CALL TO ORDER**

Meeting called to order at 4:30 pm by Member Dobbs.

**2. ROLL CALL**

The roll was called by Administration Manager Carr.

**3. ELECTION OF OFFICERS**

Member Chilcote moved to keep Member Dobbs as President and that he will continue to serve as Vice-President. Member Thompson seconded the motion. All were unanimously in favor.

**4. APPROVAL OF THE MINUTES – 12-14-2021 MEETINGS**

Member Thompson moved to approve the minutes of the December 14, 2021 meeting as presented. Vice-President Chilcote seconded the motion. All were unanimously in favor.

**5. RESTROOM REPAIR UPDATE**

Administration Manager Carr advised the Commission that Town Custodian Omberg will repair fountain areas at the Mound Street and Old School Way restrooms. Once area has been repaired, he will repaint the area. The Commission may want to look at the restrooms after the painting is done. Since the buildings haven't been painted in years, the paint has faded and with the new paint done, it may be necessary to repaint the entire building. Town Custodian Omberg will also sand and repaint the exterior doors at each of these restrooms.

President Dobbs asked about the windows at the Village Green restrooms. Administration Manager Carr advised the windows needed to be taken off from the inside of the building for cleaning purposes. President Dobbs advised she would look into a stained glass look.

President Dobbs asked about installing cameras for security purposes. Administration Manager Carr advised that the past service charged a fee every time information was needed to be looked at. Vice-President Chilcote and Member Thompson will get quotes for new camera systems. Vice-President Chilcote to send information to Administration Manager Carr of the type of system he has at his business.

President Dobbs asked that Washington Street be cleaned up. There is a lot of mud remaining on the street from the storm.

President Dobbs would like signs for traffic to stop for pedestrians. See if there is an alternative to flashing lights. Discussion of flashing stop signs. Not sure if these are allowed in town. Look at other communities to see what they use. Administration Manager Carr will contact INDOT.
