COMMISSION BUSINESS

1. CALL TO ORDER

Meeting called to order by Member Dobbs at 4:36 pm.

2. ROLL CALL

Administration Manager Carr called the roll.

3. APPROVAL OF MINUTES – 3-14-2023, 4-11-2023 AND 5-04-2023 MEETINGS

Member Martin made a motion to approve the minutes from 3-14-2023, 4-11-2023 and 5-4-2023 as presented. Member Nickel seconded the motion. All were unanimously in favor.

4. UPDATE ON WATER FOUNTAIN UPGRADE AT VILLAGE GREEN PAVILION

Member Nickel knows Cameron Stone can apply a rock base to the existing water fountain. He will have Cameron contact Town Manager Jones or Administration Manager Carr.

5. DISCUSSION OF RESTROOM ATTENDANT CONTRACT

Administration Manager Carr updated the Commission about contacting cleaning services. One company estimated \$195.00 per set of restrooms and the others need to see the restrooms to submit an estimate.

Member Nickel moved to allow Town Manager Jones and Administration Manager Carr to make the cleaning company contract decision. Member Martin seconded the motion. All were unanimously in favor.

6. UPDATE LIGHTING AT PAT REILLY PARKING LOT

Member Martin moved to allow Administration Manager Carr to choose the lights. Member Nickel seconded the motion. All were unanimously in favor.

7. CONSIDER CROSSWALK STRIPING QUOTE

The Commission reviewed the estimate from AAA Striping Company for painting 7 crosswalks or installing thermoplastic; two on E. Main and four on W. Main, including the 4 corners. Discussion.

Member Nickel moved to pay \$13,000.00 for installation of thermoplastic on the seven crosswalks. Member Martin seconded the motion. All were unanimously in favor.
