**COMMISSION BUSINESS**

**1) CALL TO ORDER**

**3) APPROVAL OF THE 6-15-2023 MEETING MINUTES**

**5) DISCUSS BROWN COUNTY STONE FLOWER BEDS/GARDENS**

Cathy Paradise with Keep Brown County Beautiful was present to discuss the Brown County stone flower beds. They are in bad shape and she has a volunteer group from Cummins interested in doing a volunteer project. Cathy is proposing to remove the flower beds and flowers already planted and replace with possible pollinators or something that can be maintained. There is a honeysuckle bush in one of the flower beds that needs to be removed, since it's invasive. Melanie Hunt was present and gave her input about pollinators and how to deal with the honeysuckle bush. Brown County stone could be used for landscaping in the park or other Town areas.

Street Superintendent Jamie Sighting was present and stated he could remove the honeysuckle bush due to it being in the soil of the flower bed and not in the ground. The roots will be easy to remove. Since Jamie is the person who mows the park grounds, care needs to be taken of the placement of the flowers/pollinators.

Vice-President Shields made a motion to accept the help from Cummins for the removal of the flower beds at Lincoln Pinch Park. Member Hofstetter seconded the motion. All were unanimously in favor.

**7) ANY OTHER BUSINESS TO COME BEFORE THE COMMISSION**


Discussion of the removal of the remaining wooden play structure at the Village Green corner. The play structure is in bad shape and needs to be removed.
