

ORDINANCE 2024-06

An Ordinance Vacating in Part Ordinance 2021-20 and Establishing a Truck Loading Zone and Restrict Horse Drawn Carriage Loading Zones

WHEREAS, the Town of Nashville has in existence Ordinance 2021-20 which designates horse-drawn carriage stands on North and South Franklin Streets in the Town of Nashville; and,

WHEREAS, the Nashville Town Council has determined that the North side of Franklin Street, between Van Buren Street and Honeysuckle Lane has not been used consistently for the purpose of a Horse Drawn Carriage; and

WHEREAS, the Nashville Town Council has determined that the twenty-five (25) foot space between the intersection of the North side of Franklin Street and Van Buren Street shall remain a “No Parking” zone for motor vehicles; and

WHEREAS, the Nashville Town Council has determined that the area of twenty feet (20), between the North side of Franklin Street between Van Buren Street and Honeysuckle Lane, beginning from the end of the “No Parking” zone on Franklin Street and ending at the Honeysuckle Lane, shall remain a “Truck Loading Zone”.

IT IS THEREFORE ORDAINED AS FOLLOWS:

1. That North side of Franklin Street, from the intersection of Van Buren and Honeysuckle Lane, for a length of twenty-five (25) feet, shall remain a “No Parking” zone for motor vehicles.
2. That the North side of Franklin Street, from the end of the “No Parking” for motor vehicles zone to Honeysuckle Lane, for a length of twenty (20) feet, shall be reserved as a “Truck Loading Zone.”
3. Chapter 73, Schedule IV, “Parking Schedules” of the Town of Nashville, Indiana Code of Ordinances is hereby amended to reflect these designations.
4. All provisions of Chapter 73, Schedule IV in conflict with this amendment are hereby REPEALED.
5. Violations shall be subject to the penalties set out in Section 71.99 of said Code.
6. This ordinance shall become effective upon passage, publication and posting of appropriate signage.
