

**NASHVILLE TOWN PARK COMMISSION

ATTENDANCE BY REMOTE ACCESS: Commission Members present: President Alisha Gredy, Vice-President Alexis Caudell, Member Anna Hofstetter and Member Melanie Voland. Commission Member not present: Mark Shields. Also in attendance: Administration Manager Phyllis Carr and MS Consultant Dax Norton.

COMMISSION BUSINESS

1) CALL TO ORDER

Meeting called to order by President Gredy at 3:30 pm.

2) ROLL CALL

The roll was called by President Gredy.

3) APPROVAL OF THE MINUTES

Commission Member Voland made a motion to approve the minutes from the 9-17-2020 meeting as presented. Member Hofstetter seconded the motion. Motion unanimously carried.

4) DISCUSSION OF PARK PROJECT

Vice-President Caudell emailed a photo of the dog waste receptacle filled with trash. She would like to see some trash containers placed in the park. Administration Manager Carr stated that work orders have been done for trash cans to be placed in the park and the removal of the cable antenna. Vice-President Caudell also mentioned that the maintenance and upkeep to the park looked great.

President Gredy and Vice-President Caudell will reach out to Doug Harden regarding the plans for the shelter house.

5) DISCUSSION OF FEES TO RESERVE LINCOLN PINCH PARK

Discussion of leaving the Village Green Pavilion reservation fee the same for now. The Town Park could charge a different rate when the once the park is complete.

Discussion of how to prevent people entering a private event. MS Consultant Norton mentioned there is no wording in the Pavilion contract preventing anyone from attending any event. Administration Manager Carr advised that most events at the pavilion are open to the public. Suggestion of placing signage at the park indicating a private party is being held. Commission Members suggested asking the Town Attorney if a private function could be done at the park since taxpayers pay for the park can we legally hold private functions there. Member Hofstetter asked that we consider that if an event is held at the park, we need to make sure the fee covers the cost of trash bags, labor and clean up.

Park Commission Members are to think of any fund-raising ideas to raise money for items needed at the park.

6) OTHER BUSINESS


No other business to discuss.
