

**NASHVILLE TOWN PARK COMMISSION
THURSDAY, OCTOBER 17, 2019**

Commission Members present: President Alisha Gredy, Vice-President Alexis Caudell, Member Anna Hofstetter, Member Mark Shields and Member Melanie Voland. Also in attendance: Administration Manager Phyllis Carr.

COMMISSION BUSINESS

1) CALL TO ORDER

President Gredy called the meeting to order at 3:30 p.m.

2) ROLL CALL

The roll was called by President Gredy.

3) APPROVAL OF THE MINUTES – 9-19-19 MEETING

Member Hofstetter made a motion to approve the minutes from the 9-19-19 meeting as presented. Vice-President Caudell seconded the motion. Motion unanimously carried.

4) BENCH UPDATE

1,520 pounds of lids have been collected. Commission Members discussed again the number of benches to purchase for the Town Park. They would like two benches of each color: orange, yellow, green and red. It was suggested to talk to Eagle Manufacturing at the Brown County High School to see if they can make the plaques for the benches.

Member Voland suggested having Brad Cox make an item to be placed into the park.

Member Hofstetter will talk with Brown County Democrat Editor Sara Clifford about writing an article to seek sponsors for the benches to help off-set the cost. Money that was raised by President Gredy could go towards the benches or to help with installation.

5) DISCUSSION OF TOWN PARK SKETCH IDEAS

Each Commission Member is to design the Lincoln Pinch park with the sketches provided. Landscaping, bench placement, and picnic tables, dog waste receptacle, etc. All sketches to be emailed to Vice-President Caudell or to be dropped off at her residence by Sunday, October 20, 2019. Once the plans have been received, they will be taken to Doug Harden for his help in the designing of the park.

6) ANY OTHER BUSINESS TO COME BEFORE THE COMMISSION

Administration Manager Carr advised that the Tree Board met today and asked if the Town Park Commission is still interested in the signage for native plants/trees? These signs would provide information of each plant/tree. Members agreed to proceed.

Administration Manager Carr advised she has received the dog waste receptacles. The plan is to install one receptacle at Lincoln Pinch park and the other to be installed on the Village Green.


NASHVILLE TOWN PARK COMMISSION OCTOBER 17, 2019
