AN ORDINANCE TO VACATE PORTION OF TOWN STREET MOLLY'S LANE ALSO KNOWN AS "MUSEUM LANE"

WHEREAS, The Town Council of the Town of Nashville, Indiana received a petition requesting the vacation of a town street within its corporate boundaries. to wit: that section of Molly's Lane (aka Museum Lane) from Buck Stogsdill Way to Locust Lane;

WHEREAS, due notice was given and a public hearing was conducted by the Council concerning the request;

WHEREAS, no remonstrance or objection from any aggrieved person stating any of the grounds set forth in IC 36-7-3-13 has been received; and

WHEREAS, it is in the best interest of the citizens of the Town to vacate said public way;

BE IT THEREFORE ORDAINED:

- 1. Molly's Lane (aka Museum Lane) from Buck Stogsdill Way to Locust Lane is hereby vacated as a public way.
2. The Town Clerk-Treasurer shall keep a copy of this vacation ordinance and shall furnish a copy of it to the Brown County Recorder and Auditor for recording.
3. Within thirty (30) days after the adoption of this vacation ordinance, any aggrieved person may appeal the ordinance to the Circuit Court. In the absence of such appeal, this ordinance shall become final and conclusive.
