

**ORDINANCE NO. 2023-06
TOWN OF NASHVILLE INDIANA**

AN ORDINANCE DESIGNATING ONE-WAY ALLEYS OFF VAN BUREN STREET

WHEREAS, the Town Administration of the Town of Nashville has brought to the attention of the Nashville Town Council that motor vehicle traffic during the busy tourist season has created vehicular and pedestrian safety concerns on the alleys off Van Buren Street and

WHEREAS, the Nashville Town Council believes that limiting motor vehicle traffic to one-way only may alleviate the problem, and

It is therefore **ORDAINED** as follows:

1. Pittman House Lane on the west side of Van Buren Street between Van Buren Street and Jefferson Street is hereby designated one-way Westbound. No person shall operate a motor vehicle in an eastbound direction in said designated portion of Pittman House Lane.
2. Old Hickory Lane on the east side of Van Buren Street between Van Buren Street and Old School Way is hereby designated one-way Eastbound. No person shall operate a motor vehicle in a westbound direction in said designated portion of Old Hickory Lane.
3. Old Hickory Lane on the west side of Van Buren Street between Van Buren Street and Jefferson Street is hereby designated one-way Westbound. No person shall operate a motor vehicle in an eastbound direction in said designated portion of Old Hickory Lane.
4. Molly's Lane on the west side of Van Buren Street between Van Buren Street and Jefferson Street is hereby designated one-way Westbound. No person shall operate a motor vehicle in an eastbound direction in said designated portion of Molly's Lane.
5. Printer's Lane on the west side of Van Buren Street between Van Buren Street and Jefferson Street is hereby designated one-way Westbound. No person shall operate a motor vehicle in an eastbound direction in said designated portion of Printer's Lane.
6. Town Administration shall post appropriate signage.
7. The Town of Nashville Code of Ordinances, Chapter 72, Schedule I, "One-way Streets" shall be amended to reflect this designation.
8. Violation of this ordinance shall be subject to the penalties set out in the Nashville Traffic Code. (Section 71.99 of the Town of Nashville Code of Ordinances).
9. This Ordinance shall be effective upon passage, publication and posting of signage.

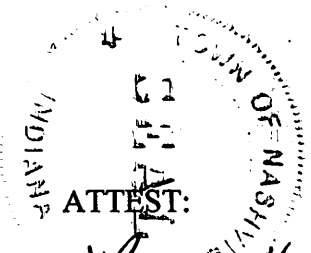
