

RESOLUTION NO. 2021-04

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF NASHVILLE,
INDIANA APPROVING CERTAIN MATTERS IN CONNECTION WITH THE 2020
CENTRAL NASHVILLE ECONOMIC DEVELOPMENT AREA**

WHEREAS, the Town of Nashville Redevelopment Commission (the “Commission”), as the governing body for the Town of Nashville Redevelopment Department, pursuant to Indiana Code 36-7-14, as amended (the “Act), on December 16, 2020 adopted a resolution (the “Declaratory Resolution”) (1) dissolving the existing Nashville Central Economic Development Area and the existing Nashville Central Allocation Area, and (2) designating an area known as the 2020 Central Nashville Economic Development Area (the “2020 Economic Development Area”) as an economic development area pursuant to Section 41 of the Act, and designating all of such area as an allocation area pursuant to Section 39 of the Act;

WHEREAS, the Declaratory Resolution approved an economic development plan for the 2020 Economic Development Area (the “2020 Plan”); and

WHEREAS, the Brown County Area Plan Commission, on February 23, 2021, approved and adopted a resolution (the “Plan Commission Order”) determining that the Declaratory Resolution and the 2020 Plan conform to the plan of development for the Town of Nashville, Indiana (the “Town”) and approving the Declaratory Resolution and the 2020 Plan.


NOW THEREFORE, BE IT RESOLVED by the Town Council of the Town of Nashville, Indiana, as follows:

1. Pursuant to Section 16(b) of the Act, the Town Council of the Town (the “Council”) determines that the Declaratory Resolution and the 2020 Plan for the 2020 Economic Development Area conform to the plan of development for the Town, and approves the Declaratory Resolution, the 2020 Plan for the 2020 Economic Development Area and the Plan Commission Order.
2. The Council hereby approves the determination that the 2020 Economic Development Area is an economic development area pursuant to Section 41 of the Act.
3. This Resolution shall be in full force and effect from and after its passage.


