Administration Manager Carr advised that the Harden Family would like to donate two benches in honor of their family members Richard & Betty Harden and Thurston & Sarah Harden and have them placed at Lincoln Pinch Park. The Harden Family owned a lot where the park is now located.

Commission Members present were all in favor of Harden's placing the benches in the park.

**6) DISCUSS PLANS FOR EXISTING CABIN/FUND RAISER IDEAS**

Member Hofstetter stated she has requested a quote for a temporary ice rink, that could be placed at the park in the winter to raise funds for the park. She will forward the quote information to all the members and discuss this at the November meeting.

No other business to discuss.


The next Town Park Commission meeting will be held on Thursday, October 21, 2021 at 3:30 p.m.
