**COMMISSION BUSINESS**

**1) CALL TO ORDER**

Meeting called to order at 3:30 pm.

**2) ROLL CALL**

President Gredy did roll call.

**3) APPROVAL OF THE 8-17-2023 MEETING MINUTES**

Member Hofstetter made a motion to approve the 8-17-2023 meeting minutes as presented. Member Cressey seconded the motion. All were unanimously in favor.


**TOWN PARK COMMISSION MEETING OCTOBER 18, 2023**
