

**NASHVILLE TOWN COUNCIL MEETING
THURSDAY, JANUARY 30, 2020**

ATTENDANCE: Council members present – President Jane Gore, Vice-President Alisha Gredy (left at 12:09pm), Councilmember Nancy Crocker, Councilmember Anna Hofstetter, and Councilmember Dave Rudd. Also in attendance – Utility Manager Sean Cassiday, Administration Manager Phyllis Carr, Town Attorney Jim Roberts, and Clerk-Treasurer Brenda Young.

COUNCIL BUSINESS – 11:45am

1) CALL TO ORDER by President Gore at 11:48am.

2) CLAIM APPROVAL

President Gore explained that the Council received a claim for Heid Rate and Regulatory Services in the amount of \$30,000.

Councilmember Hofstetter made a motion to pay the claim for Heid Rate and Regulatory Services in the amount of \$30,000. Vice-President Gredy seconded the motion. Councilmember Crocker commented that the Town Council is trying to do their best in being diligent with the people's money. All were unanimously in favor.

**3) ANY OTHER UNFINISHED BUSINESS OR COMMENTS THAT MAY COME BEFORE
THE COUNCIL**

Clerk-Treasurer Young advised that the County had asked the Town Council if they could hold their County Commission and County Council meetings at Town Hall during the 2020 early voting dates. The Town Council agreed to this last year. Clerk-Treasurer Young reported that she has since received a call from the County Clerk asking to possibly use the Town Hall as the early voting site rather than for County meetings. Clerk-Treasurer Young explained they would have to close off half the Town Hall meeting room during the early voting dates and may have to move a couple of meetings. Discussion. The Town Council will take the early voting option under consideration.

President Gore reported that she has received an email from Jenni Voris, the Town's community liaison for OCRA. Ms. Voris would like to give a presentation to the Council as to what OCRA has to offer. President Gore suggested she attend the regular Town Council meeting in February and the Council agreed to this presentation.

Administration Manager Carr presented the Town Council with census posters, cards and information. The census bureau is asking for people to apply to be census takers.

Utility Manager Cassiday reported they are getting bids to dig up the east side of the Town Hall building to address the slug infestation. Once the area is dug up, a new coating will be put on the block and it will be sealed. The current bid from Dewey Sizemore to do this work is \$9,400. Discussion.

Vice-President Gredy made a motion to spend up to \$9,400 to do the work on the building. Councilmember Crocker seconded the motion. Councilmember Hofstetter commented that she doesn't feel comfortable approving this motion without seeing a written estimate. Utility Manager Cassiday advised he was sent an email with the estimate but did not have that information before him. The motion passed 4-1, with Councilmember Hofstetter abstaining.

TOWN COUNCIL MEETING JANUARY 30, 2020

President Gore asked for an update on the Police Department. Police Chief Seastrom advised that Community Corrections has not moved into the Police Department building yet as they are waiting for the MOU with the County Commissioner's office. Also, they are trying to locate the conduit in the back of the Police Department to run fiber, once the fiber is run, they can connect to the phone box and separate the building. After the work is done, Community Corrections can move in.

Councilmember Crocker spoke about the costs of parades that are held in Town. She reached out to the President of the Shriner's Club to see if they would be willing to hold their Shriner's parade in conjunction with the Lion's Club Spring Blossom Parade. The President of the Shriner's Club advised he would take this request before the group. Police Chief Seastrom explained that the Shriner's Club at the State level is the one that makes the decision as to the dates of the parades, it is not done at the local level. Councilmember Crocker will get the contact information from Police Chief Seastrom.

Councilmember Hofstetter advised that the Council had discussed charging a fee for parades in town. She would like to revisit this discussion at a future Town Council meeting. Councilmember Crocker commented that she will try to do some research on what other communities do for parades.


4) ADJOURNMENT


