Clerk-Treasurer Young asked the Town Council if she could pay the poll workers after the election rather than waiting another month.

Councilmember Crocker made a motion to allow Clerk-Treasurer Young to pay the poll workers after the election. Councilmember Hofstetter seconded the motion. All were unanimously in favor.



5) ADJOURNMENT


