**COUNCIL BUSINESS**

**1) OPENING THE MEETING**

Vice-President Crocker made a motion to extend the Noise Ordinance Committee work for another two months. Councilmember Rudd seconded the motion. All were unanimously in favor.

**5) ADJOURN**






