He would like to have tents sent up for 80 Saturdays and removed each evening. Mr. Tilton asked if he would have to get new tents after the 60 day period. Discussion.

Administration Manager Carr was asked to check past minutes regarding the discussions of temporary structures. Indiana Landmarks Representative Renwick advised there were guidelines for temporary structures. Administration Manager Carr is to find all information pertaining temporary structures.
