## **COMMISSION BUSINESS**

#### 1. CALL TO ORDER

#### 3. APPROVAL OF THE MINUTES – 1-21-2020 WORK SESSION AND MEETING

### 4. SIGN APPLICATION

## A. QUALITY INN – HARRY PATEL – 51 W. CHESTNUT ST. – DOCKET #20-06

Carrie Mills was present to represent the sign application. She explained that they are replacing the designs of the signs only and using the existing framing. The signs will not be internally lit but will use the existing lighting.

Member Scroggins made a motion to approve sign application for Quality Inn – Docket #20-06 under guidelines Si2, Si8, Si13 and Si14. Vice-President Wes Harris seconded the motion. All were unanimously in favor.

#### 5. CERTIFICATE OF APPROPRIATENESS

## A. PNC BANK – ROBERT ZOZULA – 37 W. MAIN STREET – DOCKET #20-03

PNC Bank Representative Robert Zozula advised that they are proposing to redo the parking lot in the back of the bank. The retaining wall on the right-hand side of the lot will be removed and an ADA compliant sidewalk will be installed. They will reuse any plantings removed from this wall. And will have a 6" curb with landscaping in the remaining retaining walls. Galvanized steel rails will be powder coated with a brown color. They will mill out the parking lot and place an asphalt overlay on it and restripe the parking lot. It was recommended to repurpose any of the brown county stone if possible. They are proposing to remove sections of concrete sidewalk by the front entrance to make it ADA compliant. They are to send proposed plans for Town Administration to approve.

Member Scroggins made a motion to approve the Certificate of Appropriateness for PNC Bank – Docket #20-03 under guidelines P1, DR4, DR7, DR9, DR12, L1 and L2. Member Stephens seconded the motion. All were unanimously in favor.
