Mr. Hater will get fund raising information to the schools and place an article in the Brown County Democrat. Member Voland will put the fund-raising information on her blog. Money must be received prior to the trees being picked up in Kentucky on March 10, 2020.

5) DISCUSSION OF TOWN PARK SKETCH IDEAS

Fund raising ideas were discussed to help raise funds to go towards the park project, such as a brick sale. Discussion if the existing flower beds to be redone or repurpose the brown county stone in another way. Bench and picnic table placements? Administration Manager Carr to email the park sketch to Dynamic Concrete to get an estimate on the walkway only. After that cost comes in, then placement of the benches and picnic tables could be determined.

Administration Manager Carr advised that she had spoken with Donna Bowman regarding Cole Bowman's picnic table project for Eagle Scouts. Ms. Bowman advised he was in the process of getting all his paperwork signed so he could proceed. Once this has been completed, he will get the material list to the Commission.
