**COMMISSION BUSINESS**

**1. CALL TO ORDER**

Matt Beauchamp was present to represent the application and presented plans to install solar panels on the left hand side of the church, approximately 45 – 50 panels. This would help the church save money. The panels will be a fixed tilt all tied together, monitor the system remotely, and will be on a grid system which will allow them to use or supply to the grid. Charcoal black or cobalt blue are the colors they are looking at.

Member Patrick made a motion to approve Certificate of Appropriateness for the Nashville United Methodist Church, Docket #17-50 under guidelines: R9, R11 and NC2. Member Gould seconded the motion. All were unanimously in favor.

**5. SIGN APPLICATIONS**

**A. JANE ELLIS – BROWN COUNTY VISITORS CENTER – DOCKET #17-51**

They are proposing to install a two sided sign using the exiting sign post in front of the center. The sign will be made of a metal sign board with white and red for the background with white lettering.

Vice-President Kelley made a motion to have Administration Manager Carr to approve this sign in-house. Member Patrick seconded the motion. All were unanimously in favor.

Indiana Landmarks Representative Renwick had nothing to report.


**8. OTHER BUSINESS**


Member Gould suggested adding solar panels to the guidelines.
