AN ORDINANCE TO AMEND ORDINANCE NO. 1988-1 "BUSINESS SIGN DISTRICT S2"

WHEREAS, the recent annexation of the Orchard Hill area along State Road 135 has brought some pre-existing commercial businesses and some business zoned districts into the purview of the Town Sign Ordinance (1988-1, codified as 153.089 and 153.90), and;

WHEREAS, those businesses require larger signage for visibility from the State Highway for both commercial and safety considerations, and;

WHEREAS, similarly situated businesses along State Road 46 are included in Business Sign District S2 and are permitted larger signage;

BE IT THEREFORE ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF NASHVILLE, INDIANA that portion of Ordinance 1988-1 codified as Section 153.090 (A) be and is hereby AMENDED to read as follows:

(A) Business Sign District S2 includes businesses located on property abutting State Road 46 and State Road 135 North from the intersection of Pine Hills Drive to the Town limits.

All provisions of Ordinance 1988-1 in conflict with this Ordinance are hereby REPEALED.

Request: An amendment to increase the Business Sign District S2.

Petitioner: James T. Roberts, Town Attorney on behalf of the Town of Nashville.

General Findings:

- 1. The Town of Nashville Ordinance provides for two (2) specific sign districts within the town limits. Business sign district S1 includes all businesses not included in business sign district S2. Business sign district S2 includes businesses located on property abutting State Road 46.
- 2. The requirements for signs in sign district S2 are identical to those in the sign district S1 except that the maximum sign surface shall be 300 square feet whereas the maximum in the S1 sign district is 75 square feet.
- 3. The recent annexation along State Road 135 north has brought some business districts into the purview of the Town Sign Ordinance.
- 4. The Town of Nashville believes that those businesses require larger signage for visibility from the State highway for both commercial and safety considerations.
- 5. The proposed ordinance would extend the Business Sign District S2 to State Road 135 N., north from the intersection of Pine Hills Dr. to the Town limits.
