

ORDINANCE NO. 2012- 02

**A WHOLESALE WATER COST TRACKER ORDINANCE TO AMEND THE
SCHEDULE OF RATES AND CHARGES
COLLECTED BY THE TOWN OF NASHVILLE, INDIANA FOR THE USE OF WATER
SUPPLIED BY THE TOWN OF NASHVILLE, INDIANA**

WHEREAS, the Town Council of the Town of Nashville, Indiana, has determined that the existing rates and charges for the use of water supplied by the Town of Nashville to properly operate its waterworks plant, provide for depreciation, maintenance, bond and interest charges, provide for a return on its utility plant and to finance needed extensions and additions to the waterworks system are inadequate and that the existing rates and charges should therefore be increased; and

WHEREAS, it is necessary that the present rate schedules of the waterworks be increased in order to charge its customers reasonable and just rates and charge for services in accordance with Indiana Code 8-1.5-3-8; and

WHEREAS, it is necessary that the waterworks receive a reasonable rate of return on its utility plant in service pursuant to Indiana Code 8-1.5-3-8(f);

SECTION 1


There shall be and are hereby established for use of water supplied by the waterworks system of the Town of Nashville, Indiana, the following rates and charges:


