

## RESOLUTION 2011 -09

### RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF NASHVILLE, INDIANA, AUTHORIZING THE SUBMITTAL OF THE CDBG PLANNING GRANT APPLICATION TO THE INDIANA OFFICE OF COMMUNITY AND RURAL AFFAIRS AND ADDRESSING RELATED MATTERS

**WHEREAS**, the Council of the Town of Nashville, Indiana, recognizes the need to stimulate growth and to maintain a sound economy within its corporate limits: and

**WHEREAS**, The Housing and Community Development Act of 1974, as amended, authorizes the Indiana office of Community and Rural Affairs to provide grants to local units of government to meet the housing and community development needs of low-and moderate-income persons and/or the elimination of blight; and


**WHEREAS**, the Town of Nashville, Indiana, has conducted or will conduct public hearings prior to the submission of an application to the Indiana Office of Community and Rural Affairs, said public hearings to assess the housing, public facilities and economic needs of its low-and moderate-income residents:

**NOW, THEREFORE BE IT RESOLVED** by the Town Council of the Town of Nashville, Indiana, that:

1. The Town Council President is authorized to prepare and submit an application for grant funding to address revitalization of the downtown area of Nashville including: the study of the demographics and market conditions, summary analysis of existing plans and evaluation of current conditions including ADA accessibility, pedestrian and vehicular traffic flow, lighting and storm water drainage; analysis of the downtown business district's cultural and social resources; development of a proposed plan for implementation; and execute and administer a resultant grant including requisite general administration and project management, contracts and agreements pursuant to regulations of the Indiana Office of Community and Rural Affairs and the United States Department of Housing and Urban Development.
2. The Town of Nashville, Indiana, hereby commits the requisite local funds in the amount of Five Thousand Four Hundred Dollars (\$5,400.00) in the form of Economic Development Income Tax monies as matching funds for said program, such commitment to be contingent upon receipt of CDBG funding from the Indiana Office of Community and Rural Affairs.

This resolution shall be in full force and effect upon its adoption and passage.


