## **RESOLUTION 2011 – 10**

## A RESOLUTION IDENTIFYING SPECIFIC PROPERTY AND CONDITIONS AND AUTHORIZING ACTIVITIES TO ADDRESS SAID CONDITIONS IN DOWNTOWN NASHVILLE

WHEREAS, the Town Council of Nashville, Indiana, finds that certain properties located within the corporate limits of the Town of Nashville is in need of rehabilitation to eliminate conditions of physical decay which are detrimental to public safety and may be defined as blighting conditions on an area basis; and,

WHEREAS, public improvements such as streetscape - including sidewalks, curbs, storm drainage, lighting and ADA accessibility have deteriorated and contribute to a blighted condition; and

WHEREAS, The Town Council further recognizes that it is necessary for effective action and in the best interest of the Town to eliminate the widespread deterioration of downtown streetscape, which includes sidewalks, curbing, storm drainage, lighting and accessibility in order to prevent further deterioration and a greater blighting influence from developing;

WHEREAS, the downtown area has experienced a slowing or cessation of private investment over the last few years; and

NOW, THEREFORE, BE IT RESOLVED by the Town Council of Nashville, Indiana, that said property within the corporate limits of the Town of Nashville, Indiana, specifically identified as the outlining streets which are: The parameters of Pat Reilly Drive and State Road 46 East and SR135 (South), Mound (North), Jefferson (West), and Locust Lane, Artist Drive and School House Lane (East).

Streets included are:

Jefferson St (from Mound, past Pat Reilly Drive to end),

Honeysuckle Lane (from Mound to Washington)

Van Buren St/SR 135 (from Mound to SR 46 East/ SR 135)

Old School Way (from Gould to Washington)

Locust Lane (from Mound to Main)

Commercial Drive (from Main to Gould)

Artist Drive (from Old SR 46 to Gould)

School House Lane (from Van Buren/SR 135 to Main/SR 46)

SR 46/SR 135 (from Van Buren/SR135 to Snyder)

Pat Reilly Dr (from Jefferson to Van Buren/SR 135)

Washington St (from Jefferson to School House Lane)

Pittman House Lane (from Jefferson to Old School Way)

Franklin St (from Jefferson to Old School Way)

Old Hickory Lane (from Jefferson to Old School Way)

Main St (from Jefferson to Artist Dr)

Molly's Lane (from Jefferson to Van Buren/SR 135)

Gould St (from Jefferson to Artist Dr)

Printers Lane (from Jefferson to Van Buren/SR135)

Mound St (from Jefferson to Locust Lane)

BE IT FURTHER RESOLVED by the Town Council that the Town Council President is authorized to conduct surveys of public and private property within said area and/or to undertake activities to address one or more of the conditions which have contributed to the deterioration of the area, and to seek and/or utilize federal, state or private funding to support such plans or programs. This resolution replaces Resolution No. 2003-08, dated December 13, 2003.
