

**RESOLUTION NO. 2012-08**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF NASHVILLE,  
INDIANA APPROVING CERTAIN MATTERS IN CONNECTION WITH THE  
NASHVILLE CENTRAL ECONOMIC DEVELOPMENT AREA**

WHEREAS, the Town of Nashville Redevelopment Commission (the "Redevelopment Commission"), as the governing body for the Town of Nashville Department of Redevelopment (the "Department"), pursuant to Indiana Code 36-7-14, as amended (the "Act"), adopted a Declaratory Resolution on June 6, 2012 (the "Declaratory Resolution"), designating an area known as the Nashville Central Economic Development Area (the "Economic Development Area") as an economic development area pursuant to Section 41 of the Act; and

WHEREAS, the Declaratory Resolution approved an economic development plan for the Economic Development Area (the "Plan"); and

WHEREAS, the Brown County Area Plan Commission, on July 24, 2012, approved and adopted a resolution (the "Plan Commission Order") determining that the Declaratory Resolution and the Plan conform to the plan of development for the Town of Nashville, Indiana (the "Town") and approving the Declaratory Resolution and the Plan.

NOW THEREFORE, BE IT RESOLVED by the Town Council of the Town of Nashville, Indiana, as follows:


1. Pursuant to Section 16(b) of the Act, the Town Council of the Town (the "Council") determines that the Declaratory Resolution and the Plan for the Economic Development Area, in all respects, conform to the plan of development for the Town, and approves in all respects, the Declaratory Resolution, the Plan for the Economic Development Area and the Plan Commission Order.

2. The Council hereby approves the determination that the Economic Development Area is an economic development area pursuant to Section 41 of the Act.

3. This Resolution shall be in full force and effect from and after its passage.
