JOINT RESOLUTION OF THE BROWN
COUNTY BOARD OF COMMISSIONERS AND
THE NASHVILLE TOWN COUNCIL
TRANSFERRING OWNERSHIP OF THE FOUR
CORNERS VILLAGE GREEN PROPERTY TO
THE TOWN OF NASHVILLE

WHEREAS, the Four Corners Village Green Property (the "Property") is real property located in Nashville, Indiana, and which is currently owned by Brown County; and

WHEREAS, the Brown County Board of Commissioners ("Commissioners"), as the governing body of the Brown County government, have previously ordained that the Property is to be open to the public and available to be reserved on a limited basis for use by private and not-for-profit and/or tax-exempt entities consistent with its historical uses; and

WHEREAS, the Nashville Town Council ("Council"), as the governing body of the Nashville Town government has indicated a desire to take ownership of the Property; and

WHEREAS, the Commissioners and the Council have determined, after a period of public input, that transfer of the Property to the Town of Nashville would allow for a more organized and efficient use of the Property including its upkeep; and

WHEREAS, the Commissioners and the Council may utilize the provisions of I.C. 36-1-11-8, (the "Code Section") to exchange or transfer ownership in real property between governmental entities; and

WHEREAS, the Council has agreed to assume all responsibility that comes with ownership of the Property to include, but not limited to, maintenance, insurance, liability, and oversight of the Property as valuable consideration for receiving ownership of the same; and

WHEREAS, the Council has agreed to continue to make the Property available to the general public and allow it to be reserved on a limited basis for use by private and not-for-profit and/or tax-exempt entities consistent with its historical uses.

NOW, THEREFORE, BE IT RESOLVED by the BROWN COUNTY BOARD OF COMMISSIONERS and the NASHVILLE TOWN COUNCIL, as the governing bodies of the Brown County and Nashville governments, respectively, as follows:

- 1. The Commissioners hereby transfer all of the County's ownership, right, and interest in the Property to the Town.
- 2. The Council accepts ownership of the Property with all rights, responsibilities, liabilities, and obligations associated with ownership of the Property.
- 3. The ownership transfer shall be accomplished by quitclaim deed and be effective as of the date of this resolution.

- 4. The Commissioners and the Council agree that this transfer of ownership is conditioned upon the Town's continued adherence to the requirement that the Property be made available for use by the general public and for special events by private and not-for-profit entities consistent with its historical uses.
- 5. The property will never be sold or transferred except to another governmental entity subject to the same covenants and protections herein; and
- 6. No commercial development will take place on the Property, or any other addition, demolition, or modification that materially alters the physical characteristic or historical significance of the Property.
- 7. The Town will honor all present reservations on record with the County.
